RE: Adverse weather conditions

- Please note: If the school is open please ensure you send your child with a packed lunch as we cannot guarantee we
 will be able to provide a hot school dinner
- Please also ensure your child has suitable outdoor clothing and footwear

When the weather is hazardous and the school is open, we would hope that you will make every effort to bring your child to school. However, it is for you as a parent to decide whether you feel it is safe for your child to make the journey to school. Once we have children in the building we can keep them safe. However, we cannot make an assessment of each road and footpath in our community.
